

## Abstract submission guidelines & Abstracts Requirements

Abstracts should meet **all of the following specifications** in order to be considered for ISDF 2023

- Language  
Abstracts should be written in English. Abstracts will be published exactly as submitted. We kindly ask you to proofread abstracts carefully to avoid errors before they are submitted.
- Title  
Each abstract should have a brief descriptive title of maximally 20 words and should be written in sentence case. Trademarks are not allowed in the abstract title.
- Authors  
Names, institutional affiliations, cities, and countries of all contributing authors should be provided. A maximum of 15 authors per abstract is allowed. Authors' first name and middle name (if any) initials, followed by his or her last name as entered, will appear on the abstract when it will be published. Authors names will appear in the order entered by the submitting author. The presenting author (not necessarily the first author) should be identified. All communications regarding an abstract will go to the submitting author, irrespective the designation of the presenting author. Please verify that your email address (submitter and presenting author) is correct as it will be used for contacting you after the review process.
- Text  
The abstract text should not exceed 350 words. If an illustration (one allowed) is uploaded for inclusion in the abstract, the word count should be diminished by 100 words. If the word count is not reduced adequately, the ISDF 2023 organizers reserve the right to omit the illustration from the published abstract.

The abstract must include the following:

**Background/Aim:** Clearly state the purpose of the abstract.

**Methods:** Describe your selection of observations or experimental subjects clearly.

**Results:** Present your results in a logical sequence in text, table and illustrations.

**Conclusions:** Emphasize new and important aspects of the study (perhaps as a discussion section) and the conclusions that are drawn from them.

The identity of technologies (approved or experimental) mentioned should be disclosed in the abstract text or by making reference to publicly accessible sources. Trademarks may be included in the abstract text between brackets, but only once and only the first time the product/service/technology is mentioned.

No identifying features such as names of authors, hospitals, medical schools, clinics or cities may be listed in the title or abstract text, as a “blind” review process will be used. You will be asked to enter the name(s) of author(s) and their institution(s), when you submit your abstract online.

All abbreviations must be defined in first use.

Statements such as “results will be discussed” or “data will be presented” cannot be accepted.

Use of brand names: Generic names must be used for all references to products or companies. The brand name can be inserted as a reference at the bottom of the abstract page. Papers containing brand names/company names in the abstract text (i.e. not in a reference at the bottom of the page) may be rejected for this reason only. ISDF 2023 reserves the right to replace any brand name with a generic name without further notice.

- Illustration  
One figure/table/photograph may be added to an abstract. Submit graphical illustrations in jpg format and make reference to the illustration in the abstract text. Provide a brief caption for your illustration. In case an illustration is uploaded, reduce the abstract word count by 100 words.
- References  
A maximum of five literature references may be added at the end of the abstract text. State only the first author's name and bibliography (not the title of the paper) of each reference.
- Acknowledgements  
Mention all sources of funding of the work described and other acknowledgements briefly at the end of the abstract text. References and acknowledgements are included in the 350 word count for the abstract text.
- Abstract topic  
When asked to select an abstract topic from the pull-down menu, select the abstract topic matching the content of your abstract best. If none of the pre-specified topics applies to your abstract, while it fits the scope of ISDF 2023, select "Other". The organizers reserve the right to change abstract topics for the purpose of poster scheduling.
- Keywords  
Provide at least three specific keywords, describing the content of your abstract for scheduling and indexing purposes. Avoid general terms.
